#### **Corporate Governance**


Sanmar has set high standards in corporate governance based on its ethical principles, which allow no exceptions or deviations from policy.

The Group employs a diverse and competent workforce. A conducive and invigorating work atmosphere provides employees opportunities for growth and excellence.


A strong sense of values is reinforced in each of its people processes. Employees are encouraged to strive for the zenith on a firm foundation of ethics, integrity and performance management.




