N SANKAR IN MEMORIAM

1ST MAY 2022

The ballroom at the Taj Coromandel hotel was a packed hall on 1st May 2022, at the Memoriam event organised to celebrate the life and legacy of N Sankar, Chairman, The Sanmar Group, who passed away on 17th April 2022.

Several eminent personalities from all walks of life reminisced and shared the wonderful memories and times they have had with NS. Business leaders - Arun Bharat Ram, R Seshasayee and L Lakshman, N Ram from The Hindu Publishing Group and Sports personalities - Kapil Dev, Vijay Amritraj, and Ramesh Krishnan paid rich tributes to NS. Video messages from across the world from joint venture partners, close associates and friends conveyed the admiration that he had enjoyed. NS' brother N Kumar, daughter Madhurika and grandson Manas, paid poignant tributes, while his son Vijay Sankar proposed the vote of thanks. Historian Sriram V moderated the event.

NSankar (NS) started his career as a 21-year old in Chemplast on the magic date of 4.5.67 (1967). NS made his first entrepreneurial move at the age of 26, when he acquired a major stake in the Industrial Chemicals and Monomers. There was no looking back ever since in his relentless journey of perseverance and growth.

A pioneer in “green PVC” manufacture, NS was responsible for some of the most original choices made in the field including the highly integrated manufacturing processes at the numerous facilities of Chemplast, Sanmar’s flagship company, now over fifty years old. His concept of captive power for the Caustic Chlor facility at Mettur was also a path-breaking initiative. Among other notable achievements, Chemplast was the first in the Indian Chemical Industry to develop and install a ‘Zero Liquid Discharge’ process.

NS was the architect of several successful joint venture partnerships of the Group with leading international partners in niche technology areas which have flourished over four decades, including with American

corporations such as Flowserve, BS&B, Crane, Emerson as well as with Cabot and several others. His acumen in forging these ventures and his unique ability to make them long-standing have turned out to be guiding principles for Indian industrialists looking abroad for partnerships. These partnerships are based on principles of trust, transparency and respect for intellectual property rights. NS’ bid to rope in technology to raise the quality of Indian manufacturing proved to be an enduring route for Indian businesses to raise their level of play.

Sanmar Engineering Technologies was born out of NS’ determination to bring in technology to India to manufacture products of excellence as a measure of import substitution. In 1976 he signed the first Joint Venture with Durametall (now Flowserve Corporation) of Kalamazoo, Michigan, and forayed into a wide spectrum of process industries – even India’s space missions – in need of components that principally ensure absolute safety and control. Over the decades, these joint ventures with global corporations have emerged as

models for emulation for joint venture management.

NS ventured into the Shipping business in 1994 and Sanmar Shipping Limited acquired its first ship, a bulk carrier in February 1995. Over the years under NS' stewardship, the company consolidated its position as a strong player in clean petroleum products. Sanmar Shipping owns and operates a fleet of ships which trade worldwide.

With NS at the helm, The Sanmar Group has become a multinational

with global footprints in the USA, Mexico, and Egypt, other than in several parts of India.

NS established The Sanmar Group of companies that have earned a name for themselves in a highly competitive market. They stand for integrity and excellence; for growth with responsibility; for culture of innovation; for excellence in execution; for ethical business code; for a commitment to serve all constituents fairly; and with a strong sense of Corporate Social Responsibility.

Among the pioneers to separate ownership from the management, by establishing a Group Corporate Board, NS was known to be both a hands-off boss who would delegate and trust the professional managers. However, he was tough and demanding when it came to delivery of the work at hand.

Corporate governance was an article of faith with NS and the group echoed this philosophy in its vision statement “Combining Integrity with Excellence”.

As the engineering arm of The Sanmar Group, Sanmar Engineering Technologies caters to a wide range of process industries – even India’s space missions – in need of components that principally ensure safety where the slightest risks must be ruled out. It also has been a supplier to India’s space missions over the years.

Several successful joint ventures have followed Durametall India (now Flowserve Sanmar).

NS has over the decades ensured that these Joint Ventures (JV) with global corporations are models for emulation. He has clearly enunciated a joint venture philosophy which he summarised as:

“Both partners should appreciate the need for the joint venture. They should clearly agree on the way the JV will be managed, they must work towards a system based on trust and transparency. There must be appropriate interaction at different functional levels for the ongoing operations of the JV and clearly defined high level contacts at both ends for management decision-making on important issues calling for the involvement of both partners. Finally, both partners need to be equally able to serve the growing capital needs of the JV as it expands.”



I hope that his legacy will remain among all of you and remain among all the Danes who came across Mr Sankar. As a keen sports enthusiast, N Sankar was a patron of cricket and tennis, and had played both sports with great passion. In his younger years, he won many a doubles tournament in tennis at University and Club levels.

As a teenager, he was more inclined towards tennis, and was coached by the legendary TK Ramanathan (Ramanathan Krishnan's father) and would have gone on to a singles career in the sport but for being derailed by polio at the age of 17.

In later days, he became an able sports administrator and served as the Vice-President of the All India Tennis Association and the President of the Tamil Nadu Cricket Association and the Tamil Nadu Tennis Association. The Sanmar Group has been sponsoring the Tennis league in Chennai for over twenty-five years.

Apart from Alwarpet Cricket club, along with his father KS Narayanan, NS ran Jolly Rovers for well over 50 years, a record globally for an unbroken association between one family and one sports team. Jolly Rovers is a highly successful first-division cricket team, which gave the State and the Indian team many an illustrious player at the national and international levels.

He was also a passionate patron of the letters and arts and was chairman of Sruti Foundation, which publishes one of the country's best-known magazines on the performing arts.

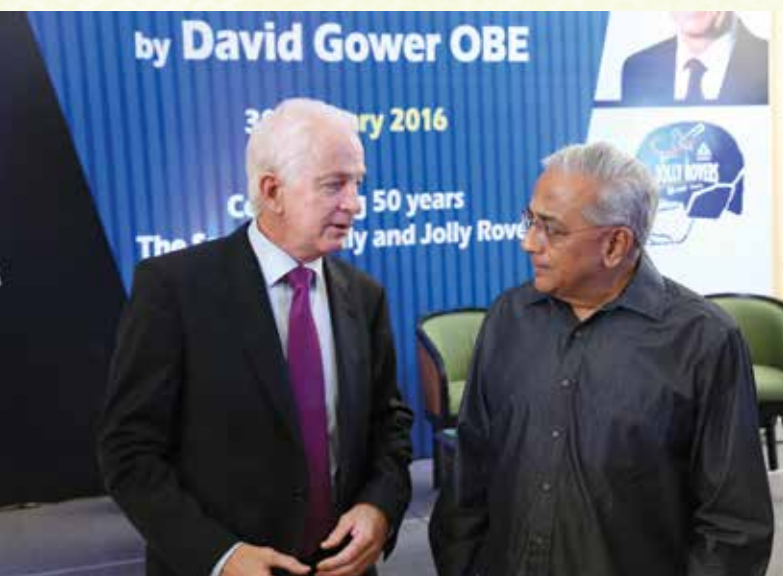

N Sankar was a generous donor and had contributed wholesomely to a number of organisations in the areas of healthcare and rehabilitation, education, social welfare, disaster relief and empowerment of the individual at society's grassroots.

Some of the organisations that have benefitted from NS' generosity include the Adyar Cancer Institute, Madhuram Narayanan Centre for Exceptional Children, Kanchi Kamakoti CHILDS Trust Hospital, Sankara Nethralaya, and the Voluntary Health Services (VHS).

The Group's flagship company, Chemplast Sanmar has long been involved in ensuring a better quality of life for the community around its plants in Mettur, Cuddalore, Karaikal, Vedaranyam and Berigai.

NS believed that to be truly successful, businesses will have to

integrate a sustainability mindset into their business models.

All of us who entered this planet leave some footprint. Some of us are happy to have just a few pebbles move around, some cut a path, some cut the grass path for others to follow, very few people can really lay a path forward, which many generations can follow. And even fewer can really look at different paths, almost radiating from the centre 360 degrees. Sankar was one who played the shots all around the field. Everyone knows that he was a very generous donor, but I think, to my mind his generosity was incidental.

For a couple of years, he was on the board of the Cancer Institute as I was and I could see the kind of clarity that he had in terms of the purpose of the institution, his impatience to make the institution become modern and his ability to be very keen on not merely

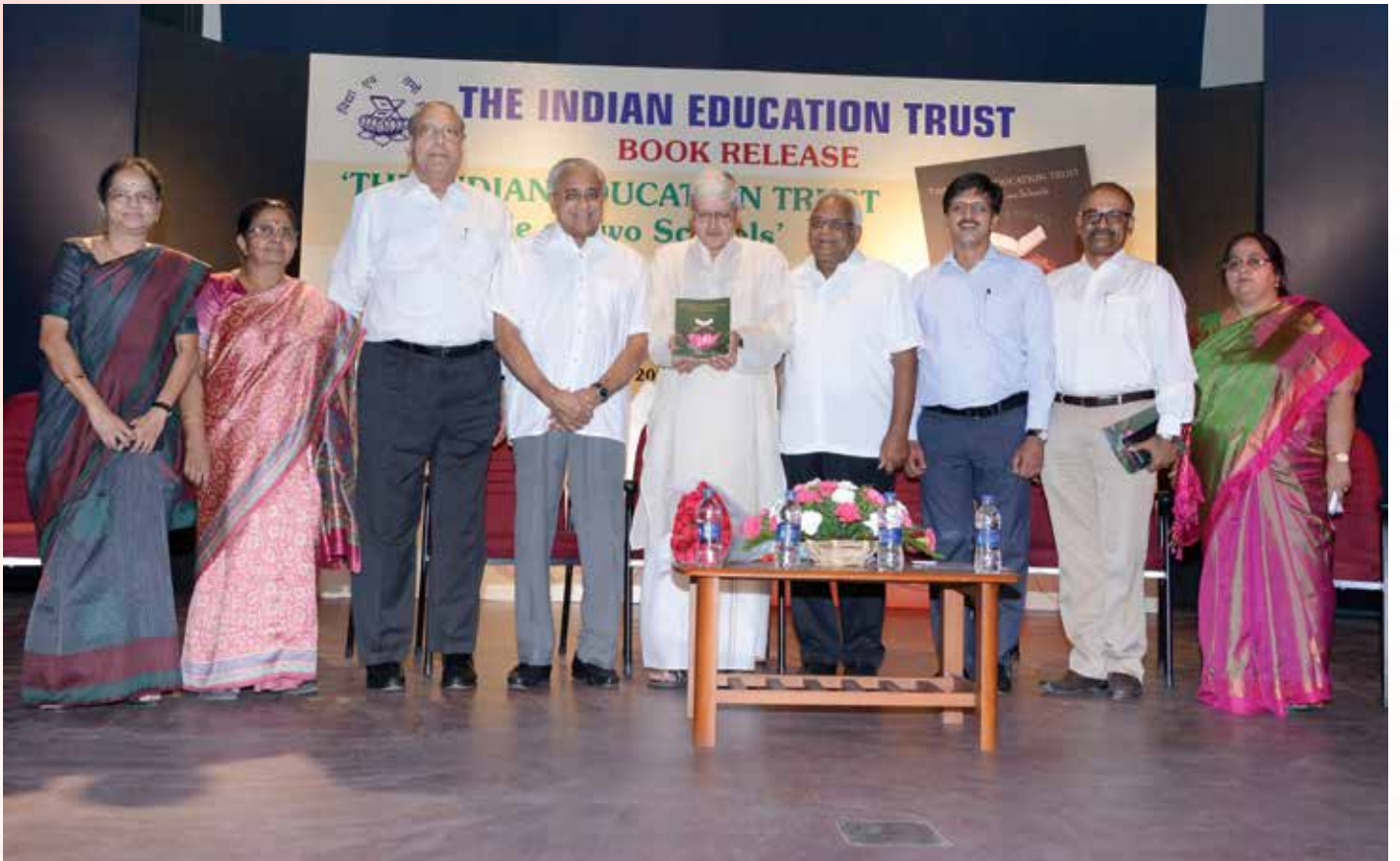

And I think the way he applied himself to the task and the purpose of life, the purpose of the institution, therefore the purpose of his life in supporting those institutions, that was a great learning to me. And that is how I was constantly reminded of the *Sathvik* way of giving. And it is not this one institution. I also know from my friends who were colleagues with Sankar on the board of the Childs Trust, that he not only gave generously (I think he gave more than 12 crores or so), but also took care in making sure the institution was sound. The very meticulous kind of detailed planning that he did for the institution - that certainly is his greatest contribution to all the classes that he supported.

During his eventful career that spans over five decades, N Sankar headed a number of industry organisations. He served as the President of ASSOCHAM (1991-92), where he played a key role in interacting with the government when economic liberalisation happened.

In the 1990s, he worked with fellow industrialists in the auto sector in Tamil Nadu to help the Jayalalithaa Government come out with the State's first industrial policy.

NS has been a highly respected figure while helming sports bodies like the Tamil Nadu as well as the All India Tennis Association, the Madras Cricket Club and Tamil Nadu Cricket Association.

He has also held other offices in several public bodies representing trade and industry, including Chairman, Indo-Danish Business Council (1987-88) Indo-US Joint Business Council (1998-99), Chairman, Madras Chamber of Commerce and Industry (1986-87) and President, Madras Management Association (1981-87).

NS served as the Honorary Consul General for Denmark in South India from 1989 till 2017, and was awarded the 'Knight of the Order of the Dannebrog, First Class' by the Danish Government in recognition of his services.

The TNCA recalls his exemplary service to the game of Cricket in Tamil Nadu. He was an astute administrator and a visionary. His demise is a huge loss to Indian cricket, especially Tamil Nadu. His immense contribution to the development of cricket and cricketers will be long remembered.

Family first and always, the guiding force



As the eldest son of Industrialist KS Narayanan and Madhuram, NS was born on November 19, 1945 at Coimbatore, Tamil Nadu.

“It was a time of great happiness for the whole family, this birth of the first child in a new generation,” said the proud father.

NS was born in an entrepreneurial family of three generations, as the son of KS Narayanan and grandson of SNN Sankaralinga Iyer, both trailblazers in the history of South Indian industry.

NS obtained his B.Sc. (Tech) in Chemical Engineering from the AC College of Technology, Madras,

graduating with distinction, and a Masters Degree from the Illinois Institute of Technology, Chicago. He joined Chemplast in 1967 to help his father and there was no turning back since then.

I have witnessed my brother looking after my father. Sacrificing a lot of his personal time and enjoyment to take care of him as our mother died early. He took care of not my father, but many others. An example is a cricketer who played for us for a long time and who's not well. Sankar ensured that he got monthly income so that he could live. This, I believe is Sankar, a really exceptional human being.

I've been with him ever since he built Sanmar, brick by brick. He took over Industrial Chemicals Limited long time ago. Anna's long-term planning and foresight had to be seen to be believed. He wrote the joint venture manual and many business schools in the US use it as a case study. His earliest joint ventures Durametallic which is now Flowserve and BS&B are now inching towards their Golden Jubilee year. On a lighter note, he always used to tell the collaborators when they talked about family businesses, he said, "You may change, but, I will still be here." Alas! it's not true anymore.

Anna was a fun-loving person played tennis regularly and enjoyed the competition. When he contracted Polio at the age of 17, while others would have stopped tennis for instance, Sankar fought fiercely and continued to play tennis.

His MCC days were filled with fun and enjoyed the camaraderie, making time for this in spite of his gruelling schedule. His two hours at the Club were important to him to relax and meet people. He loved to surround himself with friends.

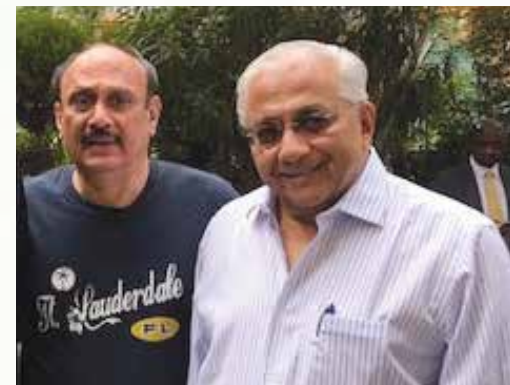

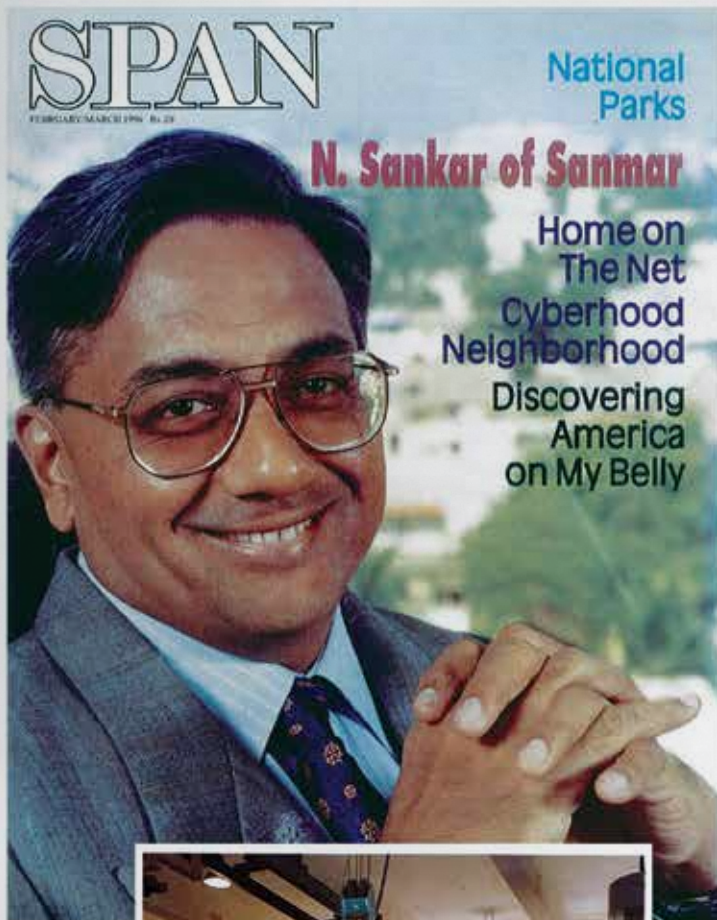

“We Won’t Rest on Our Laurels”



The Sanmar Group has a long history of collaborations with foreign companies, including eight American corporations.

"Our first joint venture was way back in 1963," says Sanmar Group Chairman N. Sankar in his Madras office overlooking the greens and whites of the city [see cover]. "That 1963 joint venture was between our Chemplast company and B.F. Goodrich Chemical Company, for the manufacture of thermoplastics. Its success paved the way for other joint ventures. When we wanted to diversify into strategic but related areas in engineering and electronics, the American companies we approached were impressed by our earlier record in joint ventures."

A chemical engineer with a master's degree from Illinois Institute of Technology, Sankar, 50, has been chairman of the Sanmar Group for 20 years. He is director of many companies outside the Sanmar Group. Under his stewardship, the Sanmar Group has expanded manyfold. He has been a strong believer in setting up collaborations with foreign companies that will bring the latest technology to India, particularly in medium engineering and electronics products that are critical to industry.

Sankar has won several awards, including, most recently, an award "for leadership in the chemical industry," presented by the Indian Institute of Chemical Engineers.

At the national level, Sankar has been president of several business organizations, such as the Associated Chambers of Commerce and Industry, the Indo-American Chamber of Commerce (Southern Region), and the Madras Management Association. He is also Denmark's Consul General for South India.

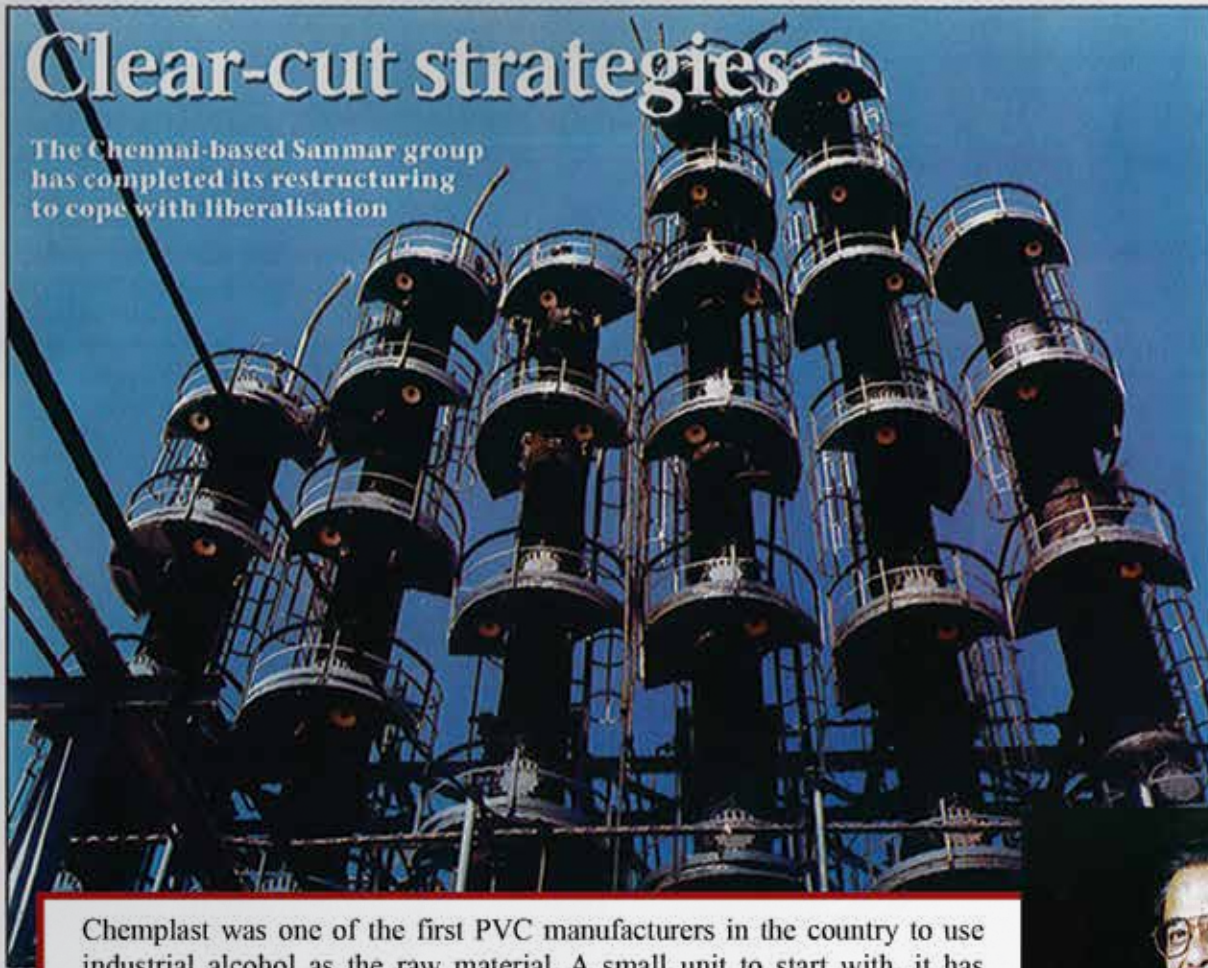
“The best advice I ever got was from my only boss, S. Ramaswamy, who was GM of Chemplast in the 1960s. I worked as his assistant to learn the business. He used to tell me that all management decisions boil down to common sense and logic, but most organisations get lost in all kinds of models and accepted practices. In 2002, our flagship, Chemplast, faced a shortage of alcohol, from which we make ethylene di-chloride (EDC) and then polyvinyl chloride. EDC imports were costly. The option was to set up a cracker to get ethylene to make EDC, but that would require a huge investment. Importing ethylene and transporting it by road to our Mettur plant was not safe. We looked at the issue

through the prism of logic. Why not import ethylene by sea, convert it to EDC at a coastal plant and then transport EDC (a safer product) to Mettur? In 2006, we did this. Had we gone with conventional wisdom, we probably would have been bankrupt by now.”

Clear-cut strategies

The Chennai-based Sanmar group has completed its restructuring to cope with liberalisation



Chemplast was one of the first PVC manufacturers in the country to use industrial alcohol as the raw material. A small unit to start with, it has expanded over the years and has now reached a capacity of 60,000 tonnes. The dawn of the 1990s saw the emergence of dominant manufacturers like Reliance and IPCL with capacities in excess of 200,000 tonnes. The smaller manufacturers—Chemplast, Finolex, DCW, and Nocil suffer from the cyclical nature of the industry as they do not have the size to cope with the ups and downs.

Sankar has had to face a lot of criticism for not going in for massive capacity expansion in PVC. "In 1991 we had a capacity of 30,000 tonnes. We were going up to 60,000 tonnes. By global definition, the relevant size would be between half a million and 1 million and if we had to go up to 1 million tonnes, it would have meant an investment of Rs 2,000 crore. Could we commit group resources of that kind to save Rs 200 crore?" he asks.

Instead, the strategy has been to concentrate on niche products like Speciality PVC, chloromethanes, and silicon PV wafers, of which Chemplast is the dominant manufacturer. Its ability to switch raw materials for PVC, its experience in being able to source raw material globally, and its early investment in self-generation in this power-intensive industry have helped it outperform its competitors.

Chennai: Sponsoring and nurturing any sports team for over five decades is not a feat too many institutions can boast of. That's exactly what Sanmar Group has done with regard to Jolly Rovers. we dominated the scene. **Talking about domination, there have been incidents where Jolly Rovers faced crowd ire**

True. Such was the domination that the crowd would usually end up supporting the opposition team those days. Even if they were an outstation side, we wouldn't get the support.

How important has Bharath Reddy's contribution been in terms of talent-spotting and managing players?

When he (Bharath Reddy) joined us, he brought a lot of emphasis on spotting talent and maintaining fitness. He also lent a professional approach to the enterprise which has benefitted the side immensely.

Who would be your favourite Jolly Rovers player?

There are no favourites as

such but I would like to mention Raja (KR Rajagopal). He was one of the best players that we had. He was quite unique in his style. He would come to the ground just before the start of the match, borrow a pad and bat from someone and then go on to score a century.

Any anecdotes you could share?

Our Group has always identified with cricket. On one instance when Sunil Valson was on the flight to Chennai to turn out for us, his fellow passenger happened to be the CEO of one of our engineering companies. The two got talking and found out that they were employed with an engineering firm in South Chennai. Sunil then asked him, "which sport do you play?" Later the CEO came to me and said "looks like everyone in our company plays a sport". Another interesting incident was during the Buchi Babu match in the 70s between our team and ACC at the Loyola Grounds. Over 6000 spectators flocked to watch the match as Sunil Gavaskar was playing the game (for ACC) and the cheers were deafening.

Sportsmen were not far behind. "He was the big brother for all of us who came down to Chennai to

play cricket. No cricketer would have gone past him without benefiting from his kindness. He had passion to sports and retained it till the end," said former Indian test captain Kapil Dev. "Sankar brought beauty to the game of tennis. He would hit the ball gracefully and win with elegance," said former international tennis star Vijay Amritraj, recalling his long association with Tamil Nadu Tennis Association.

Sanmar Group deputy chairman and Sankar's son Vijay Sankar thanked the guests for taking their time out to attend the event and promised to take his father's legacy forward.

CHENNAI: On Sunday at a memoriam function, a diverse set of accomplished individuals gathered in the city to pay tributes to N Sankar of the Sanmar Group, who died last month.

Former Chairman of Sanmar group N Sankar wrote the joint venture manual which many B-Schools are using as a case study today, said N Kumar while speaking at an event organised to celebrate his brother's legacy. Sankar was involved in over 30 joint ventures, some of which have lasted for more than 25 years, as he grew the group across multiple businesses.

Sankar, 76, passed away last month after a brief illness.

Kumar also said that his brother was far ahead of his time and peers when it comes to values. Ethics, integrity and trust were a hallmark of his management.

'Understated achievements'

N Ram, Director, The Hindu Publishing Group, while recalling Sankar's work said that it was a long life of 'understated achievements'. He was not a crony capitalist and bravado, bluff and vaingloriousness was not his style, he added.

Very few people lay a path for the next generation to follow. Even fewer, like Sankar, will lay multiple paths, said R Seshasayee, former executive chairman of Ashok Leland. A generous donor, Sankar gave money without making the receiver feel small or without seeking credit for it. For him it was the cause. The money does not matter, he added revealing

the substantial donation that Sankar gave for Chennai's Cancer Institute. Sankar's many fans from across the country had descended on Chennai to celebrate his work.

Former Indian cricket captain Kapil Dev was one of them. There is no Indian cricketer who has not been touched by Sankar's kindness, he recalled adding, "He was my hero." Tennis legend Vijay Amritraj said Sankar brought beauty to the game when he played tennis. "He always won with elegance and never played to win at all cost," he said. A trait he embodied in his business as well.

Vijay Sankar, Chairman, Chemplast Sanmar and Sankar's son, said his father lived many many lives in his one life. "He was a true role model who set a remarkable legacy for us to follow," he added.
