# The Sanmar Group - Milestones

**1962**

Incorporation of the company for manufacture of PVC resins/ compounds and fabrication of PVC products.

**1967**

PVC Plant at Mettur commissioned with a capacity of 6,000 TPA, in collaboration with BF Goodrich. PVC pipes production also commences. Among the pioneers to bring PVC pipes to India.

**1976**

Flowsolve Sanmar (Durametallic) begins operations at Karapakkam, Chennai.

**1978**

At Mettur 4 MW HDO based Power Plant installed and commissioned.

**1981**

BS&B Safety Systems (India) commences commercial operations.

**1983**

Viralimalai manufacturing facility set up and Xomox begins operations.

**1984**

Smith and Crosby divisions commence commercial production of Smith Meters and Crosby Safety Relief Valves.

**1985**

Acquisition of controlling stake and take over of management of Mettur Chemicals & Industrial Corporation (MCIC) Ltd with capacities of Caustic Soda 48,000 TPA and Chloromethane 11,000 TPA.

**1988**

LSHS based captive power plant of 6.5 MW commissioned at Caustic Soda Plant, Mettur. Pioneers in captive power generation for electro-intensive industry.

**1988**

MCIC merges with Chemplast.

**1992**

Diversification into Shipping – acquisition of six bulk carriers over two years.

**1994**

Start of Sanmar Speciality Chemicals Limited.

**1998**

State-of-the-art incinerator commissioned for chlorinated hydrocarbon waste, with energy recovery features - first of its kind in India.

**1998**

Captive power generation capacity at Mettur enhanced to 48.5 MW - self sufficiency achieved in power requirements.

**1999**

Formation of Tyco Sanmar.

Fumed silica - JV with Cabot Corporation.

Shipping business spun off as an independent company.

**2000**

Dedication of Tyco Sanmar at Viralimalai. Sanmar Engineering Services commences activities.

Inauguration of state-of-the-art Investment Castings facility at Viralimalai.

**2003**

Acquisition of Kothari Sugars & Chemicals, caustic soda plant at Karaikal and merger with Chemplast Sanmar.

Acquisition of TCI Sanmar Chemicals, Egypt.

Xomox Sanmar JV with Crane - Energy Flow Solutions for manufacture of Pacific Seal Valves.

Matrix Metals LLC, acquired in the US.

## 2009

Xomox Sanmar inaugurates Pacific Valves Division.

State-of-the-art greenfield PVC project commissioned with a capacity of 170,000 TPA at Cuddalore, along with a Marine Terminal facility for import of VCM.
